The law states that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided the correct information, the Office of Financial Aid will compare your FAFSA with the information on this worksheet along with other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and <u>submit all documents to the Office of Financial Aid</u>.
